

RESOLUTION NO. 2018-121

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE MARICOPA COUNTY REGULAR GENERAL ELECTION HELD ON NOVEMBER 6, 2018.

WHEREAS, the City of Peoria, Arizona did hold a general election on November 6, 2018; and




