RESOLUTION NO 2016-97

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE MARICOPA COUNTY REGULAR PRIMARY ELECTION HELD ON AUGUST 30, 2016; AND ORDERING THE RECORDING OF SUCH RESOLUTION AND CHARTER AMENDMENT CERTIFICATION.

WHEREAS, on April 19, 2016 the Mayor and City Council of the City of Peoria, Maricopa County, Arizona, did take action to direct and authorize the City Clerk and City Attorney to take all steps necessary to conduct a Primary Election on the 30th day of August, 2016 and, if necessary, a General Election on the 8th day of November, 2016; and

WHEREAS, the City of Peoria, Maricopa County, Arizona, by Resolution Numbers 2016-40A, 2016-40B and 2016-40C, adopted on April 19, 2016; did cause to be submitted to the qualified electors of the City at a Primary Election called and held in and for the City of Peoria on the 30th day of August, 2016 three Charter amendment propositions; and

WHEREAS, the City of Peoria, Maricopa County, Arizona, by its duly appointed and acting City Clerk did issue a *Call of Election* for a Primary Election and, if necessary, General Election on the 20th day of May, 2016 and the 27th day of May, 2016; and did cause to be submitted to the qualified electors of the City a Primary Election called and held in and for the City of Peoria on the 30th day of August, 2016 an election for Councilmembers for the Ironwood, Mesquite and Willow Districts; and

WHEREAS, the City of Peoria, Maricopa County, Arizona, by its duly appointed and acting City Clerk did cause a notice for a Primary Election by publishing a *Notice of Election* thereof in the Peoria Times and La Voz newspapers as provided by law, such newspapers published in and having general circulation within said City, that said notice as so published did specify the place whereat such election was to be held, and the questions to be voted upon, copy of said *Notice of Election* with the *Affidavits of Publication* attached hereto Exhibit "A" – *Affidavits of Publication and Notice of Election*, being now on file and a part of the official records of the City Council of the City of Peoria; and

WHEREAS, the election returns are presented to and hereby canvassed by the City Council.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the City of Peoria, Maricopa County, Arizona, as follows:

SECTION 1. That the total number of ballots cast and total voter turnout at said regular Primary Election is shown by the final results as issued by the Maricopa County Recorder.

SECTION 2. That the total number of votes cast for each candidate and the total number of votes for and against each proposition at each precinct at said regular Primary Election is shown by the final results as issued by the Maricopa County Recorder.

SECTION 3. That the total number of provisional ballots, the total number of provisional ballots tabulated, and the total number of provisional ballots found to be invalid and not counted at said regular Primary Election is shown by the final results as issued by the Maricopa County Recorder.

SECTION 4. That the total number of rejected ballots by precinct is shown by the final results issued by the Maricopa County Recorder.

SECTION 5. That the total number of votes cast at said regular Primary Election, for the candidates of Councilmember by District are as follows:
