RESOLUTION NO 2014-129

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE REGULAR PRIMARY ELECTION HELD ON AUGUST 26, 2014; AND ORDERING THE RECORDING OF SUCH RESOLUTION AND CHARTER AMENDMENT CERTIFICATION.

WHEREAS, on April 22, 2014 the Mayor and City Council of the City of Peoria, Maricopa County, Arizona, did take action to direct and authorize the City Clerk and City Attorney to take all steps necessary to conduct a citywide Primary Election on the 26th day of August, 2014 and, if necessary, a General Election on the 4th day of November; and

WHEREAS, the City of Peoria, Maricopa County, Arizona, by Resolution No. 2014-44, adopted on May 6, 2014; did cause to be submitted to the qualified electors of the City at a regular Primary Election called and held in and for the City of Peoria on the 26th day of August, 2014 one referendum proposition; and

WHEREAS, the City of Peoria, Maricopa County, Arizona, by its duly appointed and acting City Clerk did issue a *Call and Notice of Election* for a Primary Election and, if necessary, General Election on the 16th day of May, 2014 and the 23rd day of May, 2014; and did cause to be submitted to the qualified electors of the City at a regular Primary Election called and held in and for the City of Peoria on the 26th day of August, 2014 an election for Mayor and Councilmembers for the Acacia, Palo Verde, and Pine Districts; and

WHEREAS, the City of Peoria, Maricopa County, Arizona, by its duly appointed and acting City Clerk did cause notice of the regular Primary Election by publishing the *Notice of Election* thereof in the Peoria Times newspaper as provided by law, such newspaper published in and having general circulation within said City, that said notice as so published did specify the place whereat such election was to be held, and the questions to be voted upon, copy of said *Notice of Election* with the *Affidavits of Publication* attached hereto Exhibit "A" – *Affidavits of Publication and Notice of Election*, being now on file and a part of the official records of the City Council of the City of Peoria; and

WHEREAS, the election returns are presented to and hereby canvassed by the City Council.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the City of Peoria, Maricopa County, Arizona, as follows:

SECTION 1. That the total number of ballots cast and total voter turnout at said regular Primary Election, as shown by the final results as issued by the Maricopa County Recorder, is set forth on Exhibit "B" - Summary Report, attached and incorporated to this resolution.

SECTION 2. That the total number of votes cast for each candidate and the total number of votes for and against the proposition at each precinct at said regular Primary Election, as shown by the final results as issued by the Maricopa County Recorder, is set forth on Exhibit "C" – Maricopa County Precinct Canvass, attached and incorporated to this resolution.

SECTION 3. That the total number of provisional ballots, the total number of provisional ballots tabulated, and the total number of provisional ballots found to be invalid and not counted at said regular Primary Election, as shown by the final results, is set forth on Exhibit "D" – Provisional Ballots HAVA Requirements, attached and incorporated to this resolution.

SECTION 4. That the total number of rejected ballots by precinct, as shown by the final results, is set forth on Exhibit "E" – Rejected Ballots by Precinct, attached and incorporated to this resolution.





RESOLUTION NO. 2014-44

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, MARICOPA COUNTY, ARIZONA PROPOSING AN AMENDMENT TO THE CITY OF PEORIA, ARIZONA, CITY CHARTER, AMENDING ARTICLE II, SECTION 14 PERTAINING TO MEETINGS OF BOARDS, COMMISSIONS AND COMMITTEES AND ARTICLE II, SECTION 15 PERTAINING TO SPECIAL MEETINGS AND PROVIDING FOR AN EFFECTIVE DATE.

TEXT OF PROPOSED AMENDMENT

IT IS RESOLVED by the Mayor and Council of the City of Peoria:

1. The following amendment of Article II, Sections 14 and 15 is proposed to become valid when approved by a majority of the qualified electors voting thereon and upon proclamation of Mayor after completion of the official canvass in accordance with Article X, Section 2 of the Peoria City Charter.

2. The Charter of the City of Peoria, Arizona is amended by amending Article II, Section 14 to read as follows:

ARTICLE II. THE COUNCIL

Sec. 14. Meetings of council, boards, commissions and committees.

A. The council shall meet regularly at such times and at such places as may be prescribed by ordinance, but not less frequently than once each month. At the first meeting of the Council each year, the Council by Resolution shall adopt a proposed schedule of Regular Meetings for the year. The Resolution shall be posted in the same places as public notices of the City. The Council may modify the Resolution as it deems necessary and appropriate. Notices and agendas of such meetings, including a short summary of items on the agenda, shall be posted pursuant to statute in such public places as the council may set by ordinance, and the places of such posting shall be kept on file with the city clerk.

B. The Agenda for regularly scheduled meetings shall be set by the Mayor with input from the City Manager. A member of council may request an item be placed on a regularly scheduled agenda. Three members of the Council may request in writing that an item be placed on a regularly scheduled council agenda. Upon receipt of such request, the Mayor shall have not less than twenty-four hours to act upon such written request. If the Mayor fails to act within a reasonable time, three members of council shall file a written request to place the item on the agenda with the City Manager and City Clerk. The item shall then be placed on the next regular scheduled meeting agenda.

C. All meetings of the city's council, boards, commissions and committees shall be open to the public, provided that executive sessions may be held as provided by statute.

~~D.~~ Minutes of executive sessions shall be kept confidential except from members of the body which met in executive session and from a city officer, appointee or employee who is the subject of discussion or consideration during an executive session of the public body held for the purpose of discussion or consideration of his employment, assignment, appointment, promotion, demotion, dismissal, salary, disciplining or resignation.

3. The Charter of the City of Peoria, Arizona is amended by amending Article II, Section 15 to read as follows:

Sec. 15. Special meetings

~~A. The Mayor may, or at the request of three (3) members of the council, shall, by giving notice thereof to all members of the council, or by leaving notice at their usual place of abode, call a special meeting of the council for a time not earlier than twenty-four (24) hours after notice is given and posted pursuant to law. Special meetings of the council may also be held at any time by the common consent of four (4) members of the council, provided notice is given and posted as in special meetings called by the Mayor.~~

A. Special meetings of the Council shall be held in accordance with the following:

1. Upon not less than twenty four hours after notice is given and posted pursuant to law.
2. Upon request of the Mayor or if the Mayor is absent or fails to act, then upon written request of three members of Council filed with the Mayor. The Mayor shall have not less than twenty-four hours to act upon such a written request. In the event the Mayor fails to act, three members of Council shall file a written request for a special meeting with the City Manager and City Clerk.
3. Notice shall be given to all Council members by the City Clerk in the manner most practicable.
4. Special meetings shall be scheduled and held without undue delay.

4. The proposed amendment approved by the Mayor and a majority of the members of the City Council and entered into the minutes shall be submitted by the Peoria City Clerk to the qualified electors of the City at the August 26, 2014 regular municipal election as provided by Article X, Section 2 of the Peoria City Charter.

5. This Resolution shall become effective in the manner provided by law.

En la primera sesión del Concejo cada año, el Concejo por Resolución deberá adoptar un propuesto programa de Sesiones Regulares para el año. La Resolución se deberá fijar en los mismos lugares como los avisos públicos de la Ciudad. El Concejo puede modificar la Resolución como determine ser necesario y apropiado. Sección 15. Sesiones especiales

~~A. El Alcalde puede, o al ser solicitado por tres (3) miembros del concejo, deberá, a través de aviso de eso a todos los miembros del concejo, o por dejando el aviso en sus lugares usuales de residencia, convocar una sesión especial del concejo para una hora no más temprana que de veinticuatro (24) horas después de dar aviso y fijado de acuerdo con la ley. En el caso de que el Alcalde falle actuar, tres miembros del Concejo deberán entablar una solicitud por escrito de una sesión especial con el Administrador de la Ciudad y la Secretaria Municipal.
 3. El aviso se deberá ofrecer a todos los miembros del Concejo por la Secretaria Municipal de una manera más práctica.
 4. Las sesiones especiales se deberán programar y se deberán celebrar sin aplazar indebido
4.
