RESOLUTION NO 06-140

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE REGULAR PRIMARY ELECTION HELD ON SEPTEMBER 12, 2006; AND ORDERING THE RECORDING OF SUCH RESOLUTION AND CERTIFICATE

WHEREAS, the City of Peoria, Maricopa County, Arizona, by its duly appointed and acting City Clerk did issue a call and notice for a primary and, if necessary, general election on the 18th and 25th days of May, 2006; and did cause to be submitted to the qualified electors of the City at a Regular Primary Election held in and for the City of Peoria on the 12th day of September, 2006 for the election of Mayor and Councilmembers for the Acacia, Palo Verde, and Pine Districts and Ironwood District, term expiring January 6, 2009; and

WHEREAS, the City of Peoria, Maricopa County, Arizona, by Resolution No. 06-69 adopted on April 18, 2006, did cause to be submitted to the qualified electors of the City at a Regular Primary Election called and held in and for the City of Peoria on the 12th day of September, 2006 for the purpose of submitting to the qualified electors of the City one referendum; and

WHEREAS, the City Council did cause notice of the Regular Primary Election to be given by the City Clerk publishing notice thereof in the Arizona Business Gazette newspaper as provided by law, such newspaper published in and having general circulation within said City, that said notice as so published did specify the place whereat such election was to be held, and the questions to be voted upon, copy of said notice with the affidavit of publication attached thereto, being now on file and a part of the official records of the City Council of the City of Peoria; and

WHEREAS, the election returns have been presented to and been canvassed by the City Council.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the City of Peoria, Maricopa County, Arizona, as follows:

SECTION 1. That the total number of ballots cast and total voter turnout at said Regular Primary Election, as shown by the final results as issued by the Maricopa County Recorder, is set forth on Exhibit "A"- Summary Report, attached to and incorporated to this resolution.

SECTION 2. That the total number of votes cast for each candidate and the total number of votes for and against the proposition at each precinct at said Regular Primary Election, as shown by the final results as issued by the Maricopa County Recorder, is set forth on Exhibit "B" – Detailed Report, attached to and incorporated to this resolution.

SECTION 3. That the total number of provisional ballots, the total number of provisional ballots tabulated, and the total number of provisional ballots found to be invalid and not counted is set forth on Exhibit "C."


SECTION 8: That it is hereby found, determined, and declared of record that the following proposition is hereby passed having received a majority of the votes cast and shall go into effect as provided by law:



During the computation for the number of signatures required to initiate a recall petition in the Acacia District in September 2007, staff discovered a discrepancy in the September 12, 2006 Primary Election Canvass. Upon my request, Maricopa County Elections who administers the Peoria Municipal Elections audited the Precinct Canvass and identified some errors in the "Precinct by Precinct Report" within the Acacia and Pine Districts which had been manually tabulated by Maricopa County Elections.

Attached to this memo are corrected pages 13 through 16 of the Precinct by Precinct Report and a copy of the emailed memo from Maricopa County Elections detailing the corrections. The corrected typographical errors that occurred have been corrected and are reflected in red font.

This memorandum is hereby incorporated by reference as an attachment and thereby a permanent record when referencing Resolution 06-140.

Mary Jo, we have re-audited the September 12, 2006 "Precinct Canvass" as you requested and indeed we did locate some errors in the report itself. There are no errors in regards to the tabulation of the election which is reflected by the fact that the "Summary" and "Statement of Vote" are both correct and both show the correct totals for all candidates and issues presented.

The error that has occurred is limited to the "Precinct by Precinct" report which was manually created and it is only within the Acacia & Pine District pages (Pages 13 through 16) of this report. All other pages and data within the original "Precinct Canvass" report are correct and have again been verified and validated.

The typographical errors that occurred have been corrected and are reflected in red font within this newly attached version of pages 13 through 16. The errors found in this section of the report are itemized below:

Pine District

The "Ballot Cast" total should be the cumulative total of the votes shown for each precinct to include Write-in, Undervoted and Overvoted ballots. The "Ballot Cast" sum for this section was incorrectly totaled and required recalculation. Fortunately this "Ballot Cast" total is not the total that is used by your office in determining signature requirements and instead it is the total votes cast for a given candidate that is used. In this circumstance and this section, the totals reflected as "Votes" are indeed true and correct. Nonetheless, we have updated this section and pages to show a true count of what should have been reported in this "Ballots Cast" field.

Acacia District

The "Ballot Cast" total should be the cumulative total of the votes shown for each precinct to include Write-in, Undervoted and Overvoted ballots. The total manually derived for both "Ballot Cast" and "Votes" cast for candidate VICKI HUNT are incorrectly entered. In the "Votes" field, the number of votes cast for candidate VICKI HUNT are being shown as the actual total cast plus write-in ballots cast. The issue is that the write-in votes are also appearing as a separate total so any precinct where there were write-in votes, the total cumulated is duplicative of the write-in total. (Example: Precinct 0700 shows candidate VICKI HUNT with 54 and actual it is 52 + 2 write-ins. However, the write-in total is repeated in this section which meant that the "Ballots Cast" total was showing as 56 {54+2=56}). The error is only appearing on the "Precinct by Precinct" report that was manually created for this election and is not reflected on the "Summary" and "Statement of Vote". Both of these canvassing documents reflect the true and correct total of votes cast for candidate VICKI HUNT (i.e. 854). If the "Votes" cast fields were totaled from the original "Precinct by Precinct" report then the error would show a total of 871 which is the total votes cast for candidate VICKI HUNT plus write-ins (854 + 17=871).

Because of the duplication error the "Ballots Cast" total is also incorrect since this number is derived from the cumulative total of the votes shown for each precinct to include Write-in, Undervoted and Overvoted ballots. Pages 13 & 14 of this newly revised version has the duplicative write-in error corrected and the new "Ballots Cast" figure is reflective of this.

Mary Jo, my apologies for the error that has occurred and moreover for any inconvenience that this
