2. **ENFORCEMENT & PERMITS** – Decisions made by the Special Events Staff, and the City of Peoria are final. Vendor will comply with all laws and regulations. Vendor is responsible for obtaining necessary permits and licenses to operate and/or sell at this event. All permits, licenses and forms must be on display at the vendor's booth space.
3. **LIABILITY** – Vendor covenants that it will protect, hold harmless & indemnify the Event, the Special Events Staff and the City of Peoria. The Event, the Special Events Staff and the City of Peoria are not liable for lost, damaged or stolen vendor property.
4. **REFUNDS** – There will be no refunds if the space is cancelled after June 1, 2008.
DAY OF EVENT: In the event of rain or other act, either man-made or natural that forces the closure of the event, the compensation is as follows: Cancellation prior to 5pm, full refund; between 5pm-7pm \$125 refund; after 7pm, no refund.
