**RECOMMENDATION:** Discussion and possible action to adopt RES. 08-~~152~~ accepting and approving the official canvass of election for the November 4, 2008 City of Peoria Special Bond and Recall Election.

**SUMMARY:**

Pursuant to state statutes, the City Council must canvass the City election that was held on November 4, 2008. The canvass is the act that declares the election results official. A.R.S. § 16-642 (A) requires that the canvass be done not less than six days nor more than twenty days. The deadline for this action is November 24, 2008.

Maricopa County is expected to canvass on November 24, 2008. As the City Clerk does not have the final results from the County, pursuant to A.R.S. § 16-642 (C), the canvass is being postponed one day and will be held on November 25, 2008.

RESOLUTION NO. 08-152

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE SPECIAL BOND AND RECALL ELECTION HELD ON NOVEMBER 4, 2008; AND ORDERING THE RECORDING OF SUCH RESOLUTION AND CERTIFICATE AND DECLARING AN EMERGENCY.

WHEREAS, the City of Peoria, Maricopa County, Arizona, by its duly appointed and acting City Clerk did issue a call and notice for a special bond election on the 11<sup>th</sup> and 25<sup>th</sup> days of July, 2008 and a special recall election on the 4<sup>th</sup>, 11<sup>th</sup>, and 18<sup>th</sup> days of July, 2008; and did cause to be submitted to the qualified electors of the City at a Special Bond and Recall Election held in and for the City of Peoria on the 4<sup>th</sup> day of November, 2008 for the election of three bond questions and the recall of a Councilmember for the Acacia District; and

WHEREAS, on June 3, 2008, the Mayor and City Council of the City of Peoria, Maricopa County, Arizona, did take action to direct and authorize the City Attorney and City Clerk to take all steps necessary to accomplish submission of three bond questions to the qualified electors of the City, at a Special Bond Election called and held in and for the City of Peoria on the 4<sup>th</sup> day of November, 2008; and

WHEREAS, on June 23, 2008, the City Clerk of the City of Peoria, Maricopa County, Arizona, officially filed Recall Petition REC 08-01 and did cause to be submitted to the qualified electors of the City at a Special Recall Election held in and for the City of Peoria on the 4<sup>th</sup> day of November, 2008 for the election of Councilmember for the Acacia District; and

WHEREAS, the Mayor and City Council did cause notice of the Special Bond and Recall Election to be given by the City Clerk publishing notice thereof in the Peoria Times newspaper as provided by law, such newspaper published in and having general circulation within said City, that said notice as so published did specify the place where at such election was to be held, and the questions to be voted upon, copy of said notice with the affidavit of publication attached thereto – Attachment "A" – Affidavit of Publication and Notice, being now on file and a part of the official records of the City Council of the City of Peoria; and

WHEREAS, the election returns have been presented to and been canvassed by the City Council.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the City of Peoria, Maricopa County, Arizona, as follows:

SECTION 1: That pursuant to A.R.S. § 35-454(D), a certificate disclosing the purpose of the Special Bond Election, the total numbers of votes cast, the total numbers of votes for and against, creating the indebtedness and whether the indebtedness is ordered, is attached as Exhibit "A" – Certificate of Bond Election.

SECTION 2: That the total number of ballots cast at said Special Bond Election, as shown by the poll lists, is set forth on Exhibit "A" - Certificate of Bond Election, attached and incorporated to this resolution.

SECTION 3. That the total number of ballots cast and total voter turnout at said Special Bond and Recall Election, as shown by the final results as issued by the Maricopa County Recorder, is set forth on Exhibit "B" - Summary Report, attached to and incorporated to this resolution.

SECTION 4. That the total number of votes cast for each candidate and the total number of votes for and against the bond questions at each precinct at said Special Bond and Recall Election, as shown by the final results as issued by the Maricopa County Recorder, is set forth on Exhibit "C" – Maricopa County Precinct Canvass, attached to and incorporated to this resolution.

SECTION 5. That the total number of provisional ballots, the total number of provisional ballots tabulated, and the total number of provisional ballots found to be invalid and not counted is set forth on Exhibit "D" – Provisional Ballots HAVA Requirements.

SECTION 6. That the total number of rejected ballots by precinct is set forth on Exhibit "E" – Rejected Ballots by Precinct.

SECTION 7. That the total number of ballots cast at said Special Bond and Recall Election, for the candidate of Councilmember were as follows:



1. That a special bond election was duly called and held in and for the City of Peoria, Arizona (hereinafter referred to as the "City"), on November 4, 2008, under the provisions of Title 35, Chapter 3, Article 3, Arizona Revised Statutes, as amended, when there was submitted to the qualified electors of the City the questions as shown on the attached form of ballots;

2. That the poll and tally lists and the official returns of the election boards that conducted the special bond election were filed with the Maricopa County Elections Department pursuant to an Intergovernmental Agreement with the City of Peoria, authorized by the duly appointed and acting officials of the City and County and on November 25, 2008 that this Mayor and Council met and canvassed the returns of the special bond election as prescribed by law;

3. That the undersigned Mayor and Council further certify that the object of the special bond election was to obtain authority from the qualified electors of the City to issue and sell the bonds described in the attached form of ballot;

4.
