

**Maricopa Association of Governments/  
Aerials Express Imagery License Agreement**

This License Agreement & Limited Warranty ("Agreement") is a legal and binding agreement between you, the Maricopa Association of Governments ("MAG"), and AEX Holdings, LLC ("Aerials Express"), an Arizona Limited Liability Company. The compressed digital aerial photography contained on the Photo DVDs and hard drive(s) are licensed by MAG for use only under the terms and conditions as set forth herein.

Installing and/or using the imagery on the Aerials Express DVDs indicates that you accept and agree to abide by the terms and conditions of this Agreement. If you do not agree to accept and honor these terms and conditions, immediately return the unused product to the Maricopa Association of Governments.

**LICENSE AGREEMENT**

**1. GRANT OF LICENSE**

Aerials Express and the Maricopa Association of Governments grant you the right to use the aerial photography stored on the 2007 Imagery DVDs and hard drive(s) on any one computer or network server that you desire provided that it is located on the premises of your business office. MAG will keep a log of all transactions for Aerials Express. You may print unlimited numbers of aerial prints using the images from the DVDs or hard drive(s). You may use the images to create small e-mail files up to fifteen megabytes uncompressed. These e-mails can be sent to your clients as part of your usual business. You may also use the images to create files for use in presentations using PowerPoint software or any other applicable software used for this task.

**2. COPYRIGHT**

You are on notice that the United States copyright laws and international treaty provisions protect the compressed digital aerial photography. You are also prohibited from removing any copyright notice contained in the digital aerial photography. You may transfer the compressed digital aerial photography to any computer hard drive at your business office.

**3. OTHER RESTRICTIONS**

- (A) You may not loan, rent, lease, sub-license, or pledge the compressed digital aerial photography or any portion thereof.
- (B) You may not sell, trade, or bargain any computer files containing any of the digital aerial photography provided to you by Aerials Express.
- (C) You may not reverse engineer, decompile, disassemble, or create derivative works from the compressed digital aerial photography, or any portion thereof.
- (D) You may not reproduce any of the digital aerial imagery for distribution in electronic formats such as CD-ROMs, Jazz Drives, or DVDs.

**4. U.S. GOVERNMENT RESTRICTED RIGHTS**

The compressed digital aerial photography and associated documentation are provided with RESTRICTED RIGHTS. Use, duplication, or disclosure by the U.S. Government is subject to restricted rights applicable to commercial computer software (Under DEARS 52.227-7013).

**5. GENERAL**

The laws of the State of Arizona shall govern this License Agreement.

**6. DIGITAL AERIAL PHOTOGRAPHY LIMITED WARRANTY**

Aerials Express makes no warranty as to the accuracy of the digital aerial photography contained on the Photo DVDs, hard drive(s) or any other data provided or sold by Aerials Express. You are expected to determine if the

accuracy and quality of the digital aerial photography will meet your specific needs.

THE ABOVE WARRANTIES ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, WHETHER EXPRESSED OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT. NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY AERIALS EXPRESS, ITS EMPLOYEES, DISTRIBUTORS, DEALERS OR AGENTS SHALL INCREASE THE SCOPE OF THE ABOVE WARRANTIES OR CREATE ANY NEW WARRANTIES.




