Water Rate Information

The City of Peoria has two charges for water: a base charge and a volume charge.

Base Charge: A fixed monthly charge based on the size of your water meter.

Volume Charge: A variable monthly charge based on the number of gallons of water used in the month.

Water Rate Consumption Categories:

Below are the water rate categories that the City of Peoria charges for consumption. For an expanded definition of the category, and the water base and volume charges, please click on the category title below.

Residential: The Residential customer classification applies to dwelling units, attached or detached, served by an individual water meter in which only a single family resides. Examples include, but are not limited to, single family detached homes, townhouses, condominiums, and mobile homes. Townhouses, condominiums, and mobile home units with more than one unit serviced by a single meter do not fall under the single-family residential category.

Multi-Residential: The multi-residential water category applies when more than one dwelling unit is served by a single master meter.

Commercial/Industrial: The Commercial/Industrial customer classification applies to units wherein persons or families do not normally reside. Examples include, but are not limited to, general offices, retail stores with or without food, markets with or without restaurants, warehouse, manufacturing, bars with or without food, hotels, motels, public buildings, churches, clubs, lodges with or without food, medical offices, veterinary clinics, carwashes, commercial laundries, mortuaries, commercial buildings, federal buildings, restaurants, bakeries, service stations, garages, auto dealers, auto repair, out-patient medical treatment facilities, hospitals, child care centers and schools.

Residential Care: The residential care category applies when more than one dwelling unit used for personal care assistance is served by a single master meter.

Landscape: The Landscape customer classification applies to any open area unoccupied except for landscaping, which shall consist of groundcover and/or live planted material served with an irrigation system. Examples include, but are not limited to, landscaped areas, strip areas, right-of-ways, medians, common areas, fountains, water features, plazas, patios, decorative courtyards, sports fields, lawns, turf, swimming pools, golf courses, and water parks. These areas must not have drainage into the sewer system. If the same meter provides water to a landscaped area, swimming pool, or water feature and a bathroom, clubhouse, or other non-residential building, it would not be classified as a landscape customer. Instead, it would be classified as a commercial customer.

Non-potable: Non-potable water is untreated well water that does not meet drinking water quality standards. It is only suitable for irrigating large turf areas, filling lakes, and other non-consumption purposes. The City has identified specific conditions that may warrant the delivery of non-potable water to customers for use in closed systems where there is never any integration with the potable drinking water system. Non-potable water service shall only be provided to customers through non-potable water use service agreements. Please contact the Customer Service Center if you are interested in contracting for delivery of non-potable water.

Reclaimed: Reclaimed water is water taken from a wastewater (sewer or sewage system) stream and purified to a level suitable for further use. Reclaimed water is treated to a quality suitable for non-potable applications such as landscape irrigation, decorative water features, and non-food crops. The City has identified specific conditions that may warrant the delivery of reclaimed water to customers for use in closed systems where there is never any integration with the potable drinking water system. Reclaimed water service shall only be provided to customers through reclaimed water use service agreements. Please contact the Customer Service Center if you are interested in contracting for delivery of reclaimed water.

Wastewater Rate Information

The City of Peoria has two charges for wastewater: a base charge and a volume charge.

Base Charge: A fixed monthly charge based on the size of the water meter on the account, regardless of the amount of water usage.

Volume Charge: A monthly charge that depends on the customer type. For more information on customer type, please see below.

Wastewater Rate Consumption Categories:

The City of Peoria has two customer types for wastewater rate calculations: Residential and Commercial/Industrial. For an expanded definition of the category, and the wastewater base and volume charges, please click on the link below.

Residential: The Residential wastewater rate schedule applies to all Residential water categories. The wastewater charge is applied to all accounts based on a winter average. The winter average is based on water usage from December, January, February and March. The winter average is calculated during these months to account for lower water usage during these cooler months. The winter average is reflected on bills beginning July 1 and will be charged until the next July, when a new winter average will be calculated.

Residential Care: The Residential Care customer classification applies to one or more dwelling units, attached or detached, served by a single or “master” water meter, in which more than one person or family may reside on either a temporary or permanent basis for the purpose of receiving medical, physical, mental, or personal care assistance. Examples include, but are not limited to, assisted living centers or complexes, nursing homes, care centers, and group homes.

Special Haul Fee

Residential - A fee of \$50.00 for every 30 minutes required to load the items, the fee will be added to your monthly utility billing.

Commercial - A fee of \$100.00 for every 30 minutes required to load the items, the fee will be added to your monthly utility billing.

*There will be an additional \$50.00 fee for large pickups that require the use of a tractor.

EPA MANDATE

The United States Environmental Protection Agency (EPA) requires that cities (including the City of Peoria) implement and maintain a program to protect the sanitary sewer system and wastewater treatment plants from wastewater discharges which may have an adverse impact on the environment. The City of Peoria has established five classifications as guidelines to implement these requirements:

Class 1- Large Industrial Users; industries whose wastewater discharge have the potential to adversely affect the sanitary sewer system (e.g. large volume metals finisher, computer chip manufacturer, pesticide manufacturer, etc.)

Class 2- Medium Industrial Users; industries whose wastewater discharge have the potential to adversely impact the sanitary sewer system and do not meet the criteria for Class 1 (e.g. radiator shops, hospitals, small to medium volume metal finishers, etc.)

Class 3- Commercial/Business accounts with grease traps or interceptors (e.g. restaurants, service stations, machine shops, grocery stores, etc.)

Class 4- Commercial/Business accounts without grease traps or interceptors (e.g. retail outlets, etc.)

Class 5- Residential and Multi-residential accounts.
