Six Great Reasons to Convert to Xeriscape

- 1. Save time** – No more mowing, fertilizing, dethatching, aerating, overseeding, or weeding.
- 2. Save water** – Xeriscape uses one-half to two-thirds LESS water than a lawn.
- 3. Save money** – Save on the cost of water, fertilizer, mowing, seed and labor.
- 4. Save landfill space** – Grass clippings take up a great deal of space in our landfills.
- 5. Cut down on pollution** – Gas-powered mowers, blowers and weed trimmers contribute to our air and noise pollution problems.
- 6. Set an example** – One good conversion begets another... you'll be surprised by the inspiration you can provide to your neighbors!

How it works

Xeriscape can create a permanent reduction in the amount of outdoor water waste, by planting environmentally sensitive landscapes. Peoria water customers that converted to Xeriscape saved an average of 19% on their water use.

A City of Peoria employee will schedule the necessary inspections and visit your property to view the site.

Required Features

The conversion must include plant material. A plant list is available at peoriaaz.gov/xeriscape. Rebates are offered based on turf removal and % low water use plant material installed.

In Peoria, water conservation is a way of life. Peoria actively protects and preserves its diverse water supply through aquifer recharge, direct reuse of reclaimed water for landscaping and other non-drinking water demands, as well as planning and building reliable water infrastructure. Our water customers also play an integral part, recognizing the importance of saving water as a key part of living in a desert environment.

Our water conservation program is working. In the past decade alone, Peoria's water customers have reduced their water consumption by an average of 15% - that's 20,400 gallons per household per year!

We hope you take advantage of Peoria's free classes, public outreach at dozens of events annually, and rebate incentives on multiple water-wise home improvement investments to save even more water.

Xeriscape Rebate Program

New Home Xeriscape

50% (size at maturity) of the total landscaping area must be low water use plants. City of Peoria water customer accounts will be credited \$150, after inspection of property and approval.

Xeriscape Conversion

Property must have a minimum of 500 square feet of turf area that will be removed. Minimum planting of 25% low water use plant material (at maturity) coverage installed in the conversion area. City of Peoria water customer accounts will be credited up to \$1650. Inspection of property required before grass is removed and after conversion is completed.

Rebate Procedure

1. Check your water bill to verify that you are a City of Peoria water customer.
2. Complete an application and scan or mail it to us. The City will contact you to schedule a preconversion measurement inspection (New Home Xeriscape excluded).
3. Install your Xeriscape or have it installed. (Save your receipt/invoice copies.)
4. Upon completion, contact us to schedule an inspection.
5. Provide copy of the receipt/invoice to City staff at inspection.
6. It may take up to 2 billing cycles for credit to post to your account.
