RESOLUTION NO. 2016-123

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE MARICOPA COUNTY REGULAR GENERAL ELECTION HELD ON NOVEMBER 8, 2016; AND ORDERING THE RECORDING OF SUCH RESOLUTION.

WHEREAS, on April 19, 2016 the Mayor and City Council of the City of Peoria, Maricopa County, Arizona, did take action to direct and authorize the City Clerk and City Attorney to take all steps necessary to conduct a Primary Election on the 30th day of August, 2016 and, if necessary, a General Election on the 8th day of November, 2016; and

WHEREAS, the City of Peoria, Maricopa County, Arizona, by Resolution Number 2016-91, adopted on July 5, 2016; did cause to be submitted to the qualified electors of the City at a General Election called and held in and for the City of Peoria on the 8th day of November one Tax Code Amendment proposition; and

WHEREAS, the City of Peoria, Maricopa County, Arizona, by its duly appointed and acting City Clerk did issue a *Call of Election* on the 7th day of October, 2016 and the 14th day of October, 2016 for a General Election; and did cause to be submitted to the qualified electors of the City a General Election called and held in and for the City of Peoria on the 8th day of November, 2016; and

WHEREAS, the City of Peoria, Maricopa County, Arizona, by its duly appointed and acting City Clerk did cause a notice for a General Election by publishing a *Notice of Election* thereof in the Peoria Times and La Voz newspapers as provided by law, such newspapers published in and having general circulation within said City, that said notice as so published did specify the place whereat such election was to be held, and the questions to be voted upon, copy of said *Notice of Election* with the *Affidavits of Publication* attached hereto Exhibit "A" – Affidavits of Publication and Notices of Election, being now on file and a part of the official records of the City Council of the City of Peoria; and

WHEREAS, the election returns are presented to and hereby canvassed by the City Council.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the City of Peoria, Maricopa County, Arizona, as follows:

SECTION 1. That the total number of ballots cast and total voter turnout at said regular General Election, as shown by the final results as issued by the Maricopa County Recorder, is set forth on Exhibit "B" – Summary Report, attached and incorporated to this resolution.

SECTION 2. That the total number of votes for and against each proposition at each precinct at said regular General Election, as shown by the final results as issued by the Maricopa County Recorder, is set forth on Exhibit "C" – Maricopa County Precinct Canvass, attached and incorporated to this resolution.

SECTION 3. That the total number of provisional ballots, the total number of provisional ballots tabulated, and the total number of provisional ballots found to be invalid and not counted at said regular General Election, as shown by the final results as issued by the Maricopa County Recorder, is set forth on Exhibit "D" – Provisional Ballots HAVA Requirements, attached and incorporated to this resolution.

SECTION 4. That the total number of rejected ballots by precinct at said regular General Election, as shown by the final results issued by the Maricopa County Recorder, is set forth on Exhibit "E" – Rejected Ballots by Precinct, attached and incorporated to this resolution.

SECTION 5: That it is hereby found, determined, and declared of record that the following ballot issue did not receive the approval of a majority of the electors of the City voting on the question at the regular General Election, and that the issue did not pass:

Proposition 400 – Code amendment to increase the sales tax by 4/10 of 1% with revenues restricted to funding public safety personnel, equipment and facilities to enhance the public safety presence in the community; preserving desert open spaces; enhancing parks and recreational amenities; expanding trails; and improving shade and streetscapes. (Resolution No. 2016-91)







RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, ARIZONA, DECLARING ITS INTENTION TO ORDER THE IMPROVEMENTS OF A CERTAIN AREA WITHIN THE CORPORATE LIMITS OF THE CITY AND CREATING AN IMPROVEMENT DISTRICT KNOWN AS THE CITY OF PEORIA MAINTENANCE IMPROVEMENT DISTRICT NO. 1198, BLACKSTONE AT VISTANCIA PARCEL B9, PROVIDING THAT THE COST OF THE MAINTENANCE OF THE LANDSCAPING INCLUDED WITHIN, NEAR, AND ADJACENT TO A PARKWAY AND RELATED FACILITIES TOGETHER WITH APPURTENANT STRUCTURES AS SHOWN ON THE PLANS, SHALL BE ASSESSED UNDER THE PROVISIONS OF TITLE 48, CHAPTER 4, ARTICLE 2, ARIZONA REVISED STATUTES, AS AMENDED; AND DECLARING AN EMERGENCY.

SECTION 1. The public interest or convenience results and it is the intention of the Mayor and Council of the City of Peoria, Arizona to order the maintenance of landscaping within the proposed district and that the cost of maintaining landscaping included within, near, and adjacent to a parkway and related facilities together with appurtenant structures be assessed upon a certain improvement district to be known as Peoria Maintenance Improvement District No. 1198.

The estimate of the cost and expenses for the maintenance of the landscaping on file with the Superintendent of Streets and the City Clerk is approved and adopted by the Mayor and Council of the City.

SECTION 2. The maintenance of the landscaping, therefore, in the opinion of the Mayor and Council of the City, are of more than local or ordinary public benefit, and are of special benefit to the respective lots, pieces and parcels of land within the real property described herein. The Mayor and Council of the City make and order that the cost and expenses for the maintenance of the landscaping included within, near, and adjacent to a parkway and related facilities together with appurtenant structures be chargeable upon a district to be known and designated as the City of Peoria Maintenance Improvement District No. 1198 and as described and bounded as set forth on Exhibits A and B attached, and declare that the district in the City determined by the maintenance of landscaping included within, near, and adjacent to a parkway and related facilities together with appurtenant structures, to be assessed, to pay the costs and expenses thereof in proportion to the benefits derived therefrom.

The City shall not assess the costs and expenses for the maintenance of landscaping included within, near, and adjacent to a parkway and related facilities together with appurtenant structures, which are for the general public benefit against the respective lots, pieces and parcels of land located within the boundaries of the City of Peoria Maintenance Improvement District No. 1198 and if a portion of the costs and expenses for the maintenance of landscaping is for the general public benefit, the City shall assess the boundaries of the City of Peoria Maintenance Improvement District No. 1198 only that portion of such costs and expenses which benefits the lots, pieces and parcels of land located within the boundaries of the City of Peoria Maintenance Improvement District No. 1198.

SECTION 3. The costs and expenses for the maintenance of landscaping that be made and all proceedings therein taken; that the Superintendent of Streets of the City shall post or cause to be posted notices thereof; that the City Clerk shall certify to the passage of this Resolution of intention; that the Engineer shall prepare duplicate diagrams of the City of Peoria Maintenance Improvement District No. 1198 described in Section 2 of this Resolution to be assessed to pay the costs and expenses thereof, under and in accordance with the provisions of Title 48, Chapter 4, Article 2, Arizona Revised Statutes, as amended.

SECTION 4. The majority of owners of all of the real property within the proposed district have executed a Petition for formation of a Maintenance Improvement District and the City Council has verified the ownership of the property. Publication and posting of the notice of the passage of the Resolution of intention will be completed as prescribed by the State Statutes.

SECTION 5. Any Resolutions or parts of Resolutions in conflict with the provisions of this Resolution are hereby repealed.

SECTION 6. The immediate operation of the provisions of this Resolution is necessary for the preservation of the public peace, health and safety and an emergency is declared to exist, and this Resolution will be in full force and effect from and after its passage and approval by the Mayor and Council of the City of Peoria, Arizona as required by law and is exempt from the referendum provisions of the Constitution and laws of the State of Arizona.

ORDINANCE NO. 2016-99
AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, ARIZONA AMENDING CHAPTER 13 OF THE PEORIA CITY CODE (1992) BY AMENDING SECTION 13-107 PERTAINING TO HOME DETENTION ALTERNATIVE PROGRAM, POWERS AND DUTIES; AND PROVIDING FOR SEVERABILITY AND FOR AN EFFECTIVE DATE.
THEREFORE, it is ordained by the Mayor and Council of the City of Peoria as follows:
SECTION 1. Chapter 13 of the Peoria City Code (1992) is amended by amending Section 13-107 pertaining to Home Detention Alternative Program, Powers and Duties and which shall read as follows:

Clerk of the City are hereby approved and adopted by the Mayor and Council of the City. In addition to the requirements of law, the procedures set forth in the City Code will be followed regarding acceptance of bids and setting tax levies. For purposes of this Resolution and of all resolutions, ordinances and notices pertaining to this Resolution, the improvement as herein described is hereby designated City of Peoria Maintenance Improvement District No. 1195.
Section 3. Determination of Need.
In the opinion of the City Council, the Work is of more than local or ordinary public benefit. The City Council hereby orders that all amounts due or to become due with respect to the Work shall be chargeable upon the respective lots, pieces and parcels of land within the Assessment District.
Section 4. Preparation of Assessment Diagrams.
The City Engineer is hereby authorized and directed to prepare duplicate diagrams (Assessment Diagrams) of the property contained within the Assessment District. The diagrams shall show each separate lot, numbered consecutively, the approximate area in square feet of each lot, and the location of the lot in relation to the work proposed to be done.
Section 5. Exclusion of Certain Property.
Any public street or alley within the boundaries of the Assessment District is hereby omitted from the assessment hereafter to be made. Any lot belonging to the United States, the State, a county, city, school district or any political subdivision or institution of the State or county, which is included within the Assessment District shall be omitted from the assessment hereafter made.
Section 6. Officers Not Liable.
In no event will the City of Peoria or any officer thereof be liable for any portion of the cost of said Improvement District nor for any delinquency of persons or property assessed.
Section 7. Annual Statement.
The City Council shall make annual statements and estimates of the expenses of the District which shall be provided for by the levy and collection of ad valorem taxes upon the assessed value of all real and personal property in the District as provided in A.R.S. § 46-574 and amendments thereto.
Section 8. Enforcement Authority.
The Work and all proceedings pertaining thereto shall be performed under the provisions of Title 48, Article 2, specifically Section 46-574, and all amendments thereto and pursuant to Article 1, Section 3, (8) of the Peoria City Charter.
Section 9. Delegation of Authority.
The City Engineer is hereby authorized to fill in any blanks and to make any minor corrections necessary to complete the Plans and Specifications and the Contract Documents.






