**Purpose:**

This is a request for City Council to provide direction to City staff regarding instructions to the Maricopa County Elections Department for the Mesquite District election process.

**Background/Summary:**

On August 1, 2014 the City Clerk's Office was contacted by the Maricopa County Elections Department and informed that the Mesquite District early ballot did not contain a complete list of eligible candidates.

On August 4, 2014 the County Elections Department mailed reprinted ballots to the Mesquite District voters on the permanent early voting list.

In the afternoon of August 6, 2014 the County Elections Department reported that the same incorrect ballot reflecting an incomplete list of eligible candidates in the Mesquite District was again mailed to the early voters in the district.

**Previous Actions:**

On May 28, 2014 the City Clerk's Office provided the Maricopa County Elections Department with a list (Exhibit 1) of candidate names for the August 26, 2014 Primary Election ballot. These names were:

- Mayor – Cathy Carlat,
- Acacia District – Vicki Hunt, Sharlene Vanluven and Aaron Tiscareno,
- Palo Verde District – Ron Aames and Michael Finn,
- Pine District – Carlo Leone and Rick Murphy, and
- Mesquite District – Ben Toma, Bridget Binsbacher and Ken Krieger.

On May 29, 2014 the City Clerk's Office received the first Candidate Textual Proof from the Maricopa County Elections Department wherein changes were requested by the (Exhibit 2).

After receipt of the revised Candidate Textual Proof copies were sent to each candidate for final review and approval as required by A.R.S. §16-461.A.3.

On June 2, 2014 additional changes to the Candidate Textual Proof were submitted to the County Elections Department (Exhibit 3) and final approval for candidate names was given by the City Clerk's Office indicating no additional changes on that same day (Exhibit 4). The final Candidate Textual Proof reflected all eligible candidates for all races.

On June 16, 2014 the Mesquite District Official Ballot proof was received and approved with no changes (Exhibit 5). The proof included all three eligible Mesquite District candidates.

**Options:**

Several options will be discussed during the Council meeting.

**Staff's Recommendation:**

This is a unique situation not addressed under the statutes. The approach underlying the staff recommendation is to attempt to provide the maximum opportunity for qualified electors to participate in the election process, while attempting to follow the applicable laws to the extent possible. Based on this approach, taking in account the best interest of the voters and residents of the Mesquite District, staff recommends that the County Elections Department conduct an all-mail election using a Mesquite District, candidate-only ballot. Under this process, a mail ballot containing all of the Mesquite District Candidates will be mailed to every registered voter in the Mesquite District. Staff additionally recommends that the County provide three Remote Replacement Centers, in the Mesquite District, for voters who choose to vote a candidate-only ballot in person rather than by mail. These centers will be open until Election Day to receive ballots and permit individuals to vote a Mesquite District candidate-only ballot. Finally, all polling places serving the Mesquite District will have the Mesquite District ballot for voters to vote on Election Day.

**Fiscal Analysis:**

There will be no additional fiscal impacts to the City of Peoria.
