Definition of Commercial Purpose: Rule 123 defines commercial purpose as the use of a public record for purpose of sale, resale, or production of a document containing all or part of the copy, printout, or photograph for sale or obtaining names and addresses from such public record for the purpose of solicitation or the sale of such information to another for the purpose of solicitation or any purpose in which the purchaser can reasonably expect receipt of monetary gain from direct or indirect use of such public records. Commercial purpose does not mean the use of a public record as evidence or as research for evidence in an action in a judicial, quasi-judicial body, or political subdivision of this state. Request Processing Guidelines and Possible Costs: The amount of time necessary to process a request may vary with availability of the record(s); Scope of request; amount of equipment, materials, staff, time, record location, and other resources. Confidential information or non-public information will require redaction and may delay production. Assessable costs and fees may be required as set forth in Rule 123. Denial of any request is subject to judicial review as set forth in Rule 123.
