

RESOLUTION NO 08-136

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE REGULAR PRIMARY ELECTION HELD ON SEPTEMBER 2, 2008; AND ORDERING THE RECORDING OF SUCH RESOLUTION AND CERTIFICATE

WHEREAS, the City of Peoria, Maricopa County, Arizona, by its duly appointed and acting City Clerk did issue a call and notice for a primary and, if necessary, general election on the 9<sup>th</sup> and 23<sup>rd</sup> days of May, 2008; and did cause to be submitted to the qualified electors of the City at a Regular Primary Election held in and for the City of Peoria on the 2<sup>nd</sup> day of September, 2008 for the election of Councilmembers for the Ironwood, Mesquite, and Willow Districts; and

WHEREAS, on June 5, 2007, the Mayor and City Council of the City of Peoria, Maricopa County, Arizona, did take action to direct and authorize the City Attorney and City Clerk to take all steps necessary to accomplish submission of a franchise of Peoria Water User Association to the qualified electors of the City, at a Regular Primary Election called and held in and for the City of Peoria on the 2<sup>nd</sup> day of September, 2008; and

WHEREAS, the City of Peoria, Maricopa County, Arizona, by Resolution No. 08-43 and Resolution No. 08-44, adopted on April 1, 2008, did cause to be submitted to the qualified electors of the City at a Regular Primary Election called and held in and for the City of Peoria on the 2<sup>nd</sup> day of September, 2008 for the purpose of submitting to the qualified electors of the City two referendum propositions; and

WHEREAS, the City Council did cause notice of the Regular Primary Election to be given by the City Clerk publishing notice thereof in the Peoria Times newspaper as provided by law, such newspaper published in and having general circulation within said City, that said notice as so published did specify the place whereat such election was to be held, and the questions to be voted upon, copy of said notice with the affidavit of publication attached thereto – Attachment “A” – Affidavit of Publication and Notice, being now on file and a part of the official records of the City Council of the City of Peoria; and

WHEREAS, the election returns have been presented to and been canvassed by the City Council.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the City of Peoria, Maricopa County, Arizona, as follows:

SECTION 1. That the total number of ballots cast and total voter turnout at said Regular Primary Election, as shown by the final results as issued by the Maricopa County Recorder, is set forth on Exhibit "A" - Summary Report, attached to and incorporated to this resolution.

SECTION 2. That the total number of votes cast for each candidate and the total number of votes for and against the propositions at each precinct at said Regular Primary Election, as shown by the final results as issued by the Maricopa County Recorder, is set forth on Exhibit "B" – Maricopa County Precinct Canvass, attached to and incorporated to this resolution.

SECTION 3. That the total number of provisional ballots, the total number of provisional ballots tabulated, and the total number of provisional ballots found to be invalid and not counted is set forth on Exhibit "C" – Provisional Ballots HAVA Requirements.

SECTION 4. That the total number of rejected ballots by precinct is set forth on Exhibit "D" – Rejected Ballots by Precinct.

SECTION 5. That the total number of ballots cast at said Regular Primary Election, for the candidate of Councilmember were as follows:

SECTION 7: That it is hereby found, determined, and declared of record that the following proposition is hereby passed having received a majority of the votes cast and shall go into effect as provided by law:

Proposition 400 – Franchise agreement with Peoria Water User Association (Ordinance No. 08-30)

**Votes Yes: 8,706**  
**Votes No: 2,883**

SECTION 8: That the official title, descriptive title and the effect of a yes vote and no vote, along with the vote count thereof is set forth on Exhibit “E” attached to and incorporated to this resolution.

SECTION 9: Granting a franchise for a period of 15 years to Peoria Water User Association as approved by the qualified electors of the City of Peoria, Arizona and hereby designated as:

Ordinance No. 08-30      Peoria Water User Association

SECTION 10: That it is hereby found, determined, and declared of record that the following ballot issue did not receive the approval of a majority of the electors of the City voting on the questions at the Regular Primary Election, and that the one issue did not pass:

Proposition 401 – Charter amendment relating to the approval by the majority of voters for expenditures in excess of \$500,000 for the construction, or to aid in the construction of any arena, stadium, convention facility, sports complex, or city office building (Resolution No. 08-43)

**Votes Yes: 6,814**  
**Votes No: 7,255**

SECTION 11: That the official title, descriptive title and the effect of a yes vote and no vote, along with the vote count thereof us set forth on Exhibit “F” attached to and incorporated to this resolution.

SECTION 12: That it is hereby found, determined, and declared of record that the following proposition is hereby passed having received a majority of the votes cast and shall go into effect as provided by law:

Proposition 402 – Charter amendment relating to the required number of Council meetings held per month (Resolution No. 08-44)

**Votes Yes: 11,044**

Votes No: 3,042

SECTION 13: That the official title, descriptive title and the effect of a yes vote and no vote, along with the vote count thereof is set forth on Exhibit "G" attached to and incorporated to this resolution.

SECTION 14: That all orders or resolutions in conflict be and the same hereby are, to the extent of such conflict, hereby repealed, and that this resolution be in full force and effect immediately upon its adoption.







**DESCRIPTIVE TITLE:** Proposed franchise between the City of Peoria, Arizona and Peoria Water User Association, a public service corporation operating under the laws of the State of Arizona granting Peoria Water User Association the right to construct, maintain, and operate upon the Public rights-of-way a transmission system for distributing water.
