2R PUBLIC HEARING - Budget and Tax Levy, Fiscal Year 2011

STAFF REPORT

Clerk's Note: Items 2R and 3R were presented together.

Brent Mattingly, Finance Director, reported that the Board reviewed the proposed Budget of the Vistancia Community Facilities District Budget and tax levy information and adopted a tentative budget on June 1, 2010. Mr. Mattingly reported that the FY 2011 Final Budget is \$35.5 million.

The proposed tax rate will remain unchanged at the rate of \$2.10 per \$100 of secondary assessed value for debt service. The total tax levy revenue for the coming year is estimated to be \$2.2 million.

With regard to Agenda Item 3R, Mr. Mattingly explained that the resolution before the District Board, if approved, will provide for the adoption of the Final Budget in the amount of \$35.5 million for FY2011 and keep the tax rate for the District at the amount of \$2.10.

PUBLIC HEARING:

Board Chairperson Barrett opened the Public Hearing and asked if any Board Member or Citizen wished to comment on the Budget and Tax Levy, Fiscal Year 2011 and the Final Budget and Tax Levy, Fiscal Year 2011.

There being no comments from those present, Board Chairperson Barrett declared the Public Hearing closed.

A RESOLUTION OF THE DISTRICT BOARD OF VISTANCIA COMMUNITY FACILITIES DISTRICT (1)(A) APPROVING A FINAL BUDGET FOR FISCAL YEAR 2011 PURSUANT TO A.R.S. §48-716; (B) ORDERING THAT AN AD VALOREM TAX BE FIXED, LEVIED AND ASSESSED ON THE ASSESSED VALUE OF ALL THE REAL AND PERSONAL PROPERTY WITHIN THE BOUNDARIES OF THE DISTRICT IN AMOUNTS SPECIFIED IN FILED STATEMENTS AND ESTIMATES; AND (C) PROVIDING FOR CERTIFIED COPIES OF THIS RESOLUTION TO BE DELIVERED TO THE MARICOPA COUNTY BOARD OF SUPERVISORS AND THE ARIZONA DEPARTMENT OF REVENUE; AND (2) PROVIDING THAT THIS RESOLUTION SHALL BE EFFECTIVE AFTER ITS PASSAGE AND APPROVAL ACCORDING TO LAW.

Motion was made by Vice Board Member Aames, seconded by Board Member Leone, to adopt **RES. VCFD 2010-02** approving the Final District Budget and Tax Levy for Fiscal Year 2011 for the Vistancia Community Facilities District.

Upon vote, the motion carried unanimously 6 to 0.
