NOTICE OF HEARING

Notice is hereby given that a hearing to consider the Original application in the above-entitled captioned matter will be held on the **6th day of August, 2009 at 1:30 P.M.**, before the Arizona State Liquor Board in the Department's Hearing Room at **800 West Washington, Fifth Floor, Phoenix, Arizona.**

Notice is also given that should the application be denied, the Director may consider that action to be good cause pursuant to A.R.S. § 4-203.01(E) to cancel an Interim Permit.

The applicant and any other parties to the above-captioned proceedings are hereby notified that they have the right to appear on the date and time specified in this Notice of Hearing and have a right to be represented by legal counsel or accompanied by a court interpreter. **A listing of court interpreters recognized by the State of Arizona can be obtained through the local telephone directory or by contacting Professional Court Interpreters at (623) 873-6154.**

If the applicant or any other party fails to appear at the hearing, the Arizona State Liquor Board may proceed in their absence and a decision may be issued based upon the evidence of record.

This matter is set for hearing because the City of Peoria has recommended disapproval.

Notice is given that all written documents or briefs to be considered by the Board must be filed with the Department's Board Section **no later than two weeks prior to the date of the hearing with an original and ten copies.** Items received thereafter will be available to the Board on the date of the hearing and **may or may not be considered.**


Further notice is given that any request for a continuance or withdrawal of this application must be filed with the Department's Board Section **no later than two weeks prior to the date of the hearing.** Except when stipulated to by the Assistant Attorney General assigned to the Board, requests made thereafter must be presented orally to the Board at the time scheduled for the hearing and **may or may not be granted.**

Further notice is given that the Board has adopted the attached Order of Hearings that shall apply to this matter.

Note: Persons with a disability may request a reasonable accommodation such as sign language interpreter, by contacting the Department of Liquor Licenses and Control at (602) 542-5141. Request should be made as early as possible to allow time to arrange the accommodation.


