As a resident of Vistancia and I am requesting that City of Peoria officials set new boundary lines for the Mesquite District horizontally at Happy Valley Road to include all communities north of that boundary.

Documents provided to all Peoria residents in the "Public Participation Districting Kit" indicate the necessity to ensure "communities of interest boundaries" are kept intact. Residents living in the northern section of Peoria share common interests including, but not limited to, business development along the 303.

The horizontal division along Happy Valley Road preserves the integrity of the Mesquite District. A vertical division would separate a district homogenous in its concerns and would seem to conflict with the express intent of the redistricting process.

To reiterate, I request the Mesquite boundary line be placed horizontally at Happy Valley Road.




